Dear Sirs:

This is to inform you of recent events since my meetings with comrade Kostin in the Embassy of the Soviet Union, Mexico City, Mexico.

I was unable to remain in Mexico indefinitely because of my Mexican visa restrictions which was for 15 days only. I could not take a chance on requesting a new visa unless I used my real name, so I returned to the United States.

I had not planned to contact the Soviet embassy in Mexico so they were unprepared, had I been able to reach the Soviet Embassy in Havana as planned, the embassy there would have had time to complete our business.

Of course the Soviet embassy was not at fault, they were, as I say unprepared, the Cuban consulate was guilty of a gross breach of regulations. I am glad he has since been replaced.

The Federal Bureau of Investigation is not now interested in my activities in the progressive organization "Fair Play For Cuba Committee", of which I was secretary in New Orleans (state Louisiana) since I no longer reside in that state. However, the F.B.I. has visited us here in Dallas, Texas, on November 1st. Agent James P. Hasty warned me that if I engaged in F.P.C.C. activities in Texas the F.B.I. will again take an "interest" in me.

This agent also "suggested" to Marina Nichilayeva that she could remain in the United States under F.B.I. "protection", that is, she could defect from the Soviet Union, of course, I and my wife strongly protested these tactics by the notorious F.B.I..

Please inform us of the arrival of our Soviet entrance visa's as soon as they come.

Also, this is to inform you of the birth on October 20, 1963 of a daughter, AUDREY MARINA OSWALD in DALLAS, TEXAS, to my wife.

Friend Lee:

One time more I write you since the last time that we saw each other in Miami. The Spanish books that you took from the hotel and I have hardly anything. I told you of the man who was thinking of visiting here shortly and you ought to close the business as soon as possible, like I told you before in Miami, I recommend much prudence and do not be foolish with the money I gave you. So I hope you will not defraud me and that our dreams will be realized. After the affair I am going to recommend much to the chief that he certainly will have much interest in knowing you as they need men like you. I told him you could put out a candle at 50 meters and he did not want to believe me, but I made him believe it because I saw you with my own eyes and the chief was astonished. Good Lee, practice your Spanish for when you come to Habana for Habana is the land of the free, of the beautiful women and the rich Habana tobacco. Don't forget to do all I told you to the very letter and leave nothing that could lead to your trail and when you receive my letters destroy them as always. After the affair I will send you the money and we will see each other in Miami where always.

Havana, November 27, 1963

Dear Mr. Kennedy:

This letter is to advise you that former Marine Lee Harvey Oswald was the man who assassinated your brother by the express order of a gentleman named Pedro Charles, residing in Miami, Florida. This gentleman had an interview with him in a Miami night club about two months ago. This Mr. Pedro Charles is an agent of Fidel Castro in the United States and uses other names. Young Lee Harvey Oswald received an advance payment of \$5,000 which he spent in various night clubs, after which Pedro Charles advanced him another \$2,000. The understanding was for Lee Harvey Oswald to go first to Houston and then to Dallas where President John F. Kennedy was scheduled to pay a visit. In fact, information was available at the Chamber of Commerce of Dallas that the President would visit Texas. Pedro Charles reached an understanding with Lee Harvey Oswald, an expert marksman, for the President to be killed and for an international scandal to be unleashed so that all the blame would fall on the racists and the extreme-rightists of the State of Texas. This is the truth about the assassination of President Kennedy. I was acquainted with these details, but I never gave them any credence. I learned of them through the words of a lady who lives with Pedro Charles, who is the man who uses several false names and passports to enter and leave the United States

OR AMERICA, MEXICO AND CUBA. The lady in question, whose name I cannot disclose, lives here in Havana and is very much affected by the lamentable happenings. She never thought of what might happen because they were in the habit of kidding about everything, but this joke was reality. If the accused Lee Harvey Oswald had not been assassinated at the hands of a gambler, there is no doubt that the accused would have told the whole truth as time went on, because the first thing that **Pedro Charles** told Oswald was for him to be wide awake in doing the job and, if possible, to erase all clues and not "get caught." In addition, he was not to carry anything compromising in his pockets; anything that might prevent him from achieving the objective of his mission.

We sincerely regret the loss of President Kennedy. He was a man of peace and I, myself, feel mortified and ashamed of being a communist and of knowing a little about this matter from my conversation with this lady who knew all the details and was not brave enough to report this monstrous crime. Right now, as I am writing this report, I am preparing my effects in order to embark for Venezuela clandestinely. In fact, if the political police of Castro should arrest me I would face the firing squad. Some day the lady in question will make very interesting statements about this crime; as soon as she recuperates from her nervous state and is able to point out the mastermind behind the assassination of President Kennedy who is none other than **Pedro Charles**, agent of the State Security Department of Cuba and a fanatic of Fidel Castro.

Gentlemen:

We are hereby writing to you to let you know that the assassination of the President of the United States, John F. Kennedy, is connected with the Revolutionary Government of Cuba. Approximately two months ago the alleged assassin of the President, Lee Harvey Oswald, had an interview in Miami with Mr. **Pedro Charles**, an agent of Fidel Castro in Mexico, who had for delivery to Lee Harvey Oswald, the amount of \$7,000. The source is official, from a lady who used to accompany **Pedro Charles** to a night club in Miami and who saw them conferring together several times. This lady could not help but recognize him from photographs published here in Havana. This lady resides in Havana, but her name cannot be disclosed since her escort, **Pedro Charles**, is at the present time in Mexico on a mission for the Castro government for a cultural exchange. This lady as soon as she is able to leave the country, since she is suffering from a serious nervous breakdown, will move to a Central American country secretly, in order to avoid being detained by the Castro police. This is all the information I can provide for the time being and it is the genuine truth. Let us hope that the lady in question may be able to leave Cuba so that we can find out from her own lips all the information that has a bearing on this monstrous event in which President Kennedy lost his life.

Dear Sir:

It is my pleasure to write this letter to inform you that the assassination of President John F. Kennedy was paid for by Mr. Pedro Charles, Fidel Castro's agent in Mexico. This man became a close friend of former Marine and expert shooter Lee H. Oswald in Mexico. They were seen together frequenting various night clubs. The above-mentioned Mr. Pedro Charles had to deliver to Oswald \$7000 as a down payment. Later he was to deliver \$10,000 upon completion of the work. In other words, the crime was agreed upon for \$17,000.

Mr. Pedro Charles, who uses other fictitious names and a diplomatic passport to enter and leave Mexico and the United States, is at present in the residence of the Cuban Ambassador in Mexico, according to the latest information in my possession. I want you to know before anybody else the truth about the Dallas assassination of President Kennedy.

Dear Sir,

It is a pleasure to write you this letter to inform you that the assassination of President John F. Kennedy was paid for by Mr. Pedro, an agent of Fidel Castro in Mexico. This man befriended the ex-marine and sharpshooter Lee Harvey Oswald. They were frequently seen together on various nights. The aforementioned Mr. Pedro Charles had given Oswald \$7,000 as an advance for the preparations. Later, he handed over \$10,000 to complete the job. In other words, the crime was agreed at \$17,000.

Mr. Pedro Charles, who uses other fictitious names and a diplomatic passport to enter and leave Mexico and the United States, is currently at the residence of the Cuban ambassador to Mexico, according to the latest information in my possession.

I would like you to know before anyone else the truth concerning the assassination of President Kennedy in Dallas.

1. ON 7 DECEMBER 1962 A LETTER WAS TURNED OVER TO A REPRESENTATIVE OF THIS AGENCY. IT WAS POSTMARKED HAVANA 29 NOVEMBER 1962, SENDER JOSE MENENDEZ, 5TH AVENUE 2611, REPARTO MIRAMAR, MARIANO. IT WAS ADDRESSED TO BERNARDO MORALES, APARTADO 1624, MIAMI 1. IT WAS DELIVERED ON 4 DECEMBER 1962 TO POST OFFICE BOX 1624, MIAMI, FLORIDA.

2. POST OFFICE BOX 1624 BELONGS TO THE RADIO LIBERTAD LA VOZ
ANTI-COMUNISTA DE AMERICA. MIAMI REPRESENTATIVES OF THIS ORGANIZATION ARE OLGA DUQUE DE HEREDIA AND AIDA MAYO COETARA. SINCE MORALES WAS UNKNOWN TO THESE WOMEN, THEY TURNED THE LETTER OVER TO A CONTACT OF THIS AGENCY.

3. THE TEXT OF THE LETTER WAS: " HAVANA, 27 NOVEMBER 1962.
DEAR BERNARDO. TODAY CARLOS GAVE ME YOUR NEW P.O.BOX. THIS INFO WAS GIVEN HIM BY YOUR FRIEND MIRIAM. FOR DAYS I HAVE WANTED TO WRITE TO YOU AS I HAVE TO VARIOUS OF OUR MUTUAL FRIENDS, GIVING THEM THE INSTRUCTIONS WHICH FOLLOW AND WHICH I AM SENDING YOU. I HOPE THAT THEY WILL ARRIVE IN TIME.

NOW TO THE MATTER: I HAVE ALREADY COMMUNICATED TO "YOUR FRIENDS" OF MIAMI [REDACTED] AND PASSAIC, AND TO THOSE IN WASHINGTON, THE PRECISE INSTRUCTIONS FOR THE ATTEMPT WHICH WE ARE PLANNING AGAINST KENNEDY IN WASHINGTON, OR IF THAT SHOULD FAIL WHEN HE VISITS BRAZIL. IT IS NECESSARY TO MORTALLY STRIKE IMPERIALISM AT ITS VERY HEART. IF WE ARE ABLE TO KILL PRESIDENT KENNEDY, IT WOULD BE A GREAT SUCCESS, SUPER EXTRAORDINARY, FOR FIDEL AND FOR THE COMMUNIST LIBERATION MOVEMENT. WE CUBANS ARE THE ONES WHO ARE MARCHING WITH WORLD-WIDE COMMUNISM. WE ARE CONSOLIDATING A MARXIST-LENINIST REGIME WITHIN 90 MILES FROM THE U.S. GET AN INTERVIEW WITH THEM REPEAT GET AN INTERVIEW WITH THEM (SIC). WE HAVE TO RELY ON OUR OWN FORCES. RUSSIA CAN NOT DO IT ALL. THERE IS ENOUGH ALREADY. BELIEVE ME, IF WE ARE ABLE TO DO THIS WE WILL PARALYZE IMPERIALISM COMPLETELY. THEY WILL RESPECT FIDEL AND HIS GOVERNMENT MORE. THE TACTICS TO FOLLOW IN THE FUTURE IS ONE OF CONSTANT AGITATION THROUGHOUT AMERICA IN ORDER TO FRIGHTEN OR TERRORIZE CAPITALISM. THE IDEA IS ERRONEOUS THAT THERE HAS TO BE QUITE FOR THE TIME BEING. NO MATTER HOW DIFFICULT THE SITUATION MAY BE, ONE MUST NEVER BE AFRAID OF IMPERIALISM. DO YOU NOT SEE, THANKS TO THE SABOTAGE IN VENEZUELA, DURING THE PAST MONTH, THAT WE PARALYZED THE INVASION OF CUBA DURING THE BLOCKADE?

WE WILL ALSO COMPLETELY PARALYZE THE FUTURE PLANS OF THE UNITED STATES IN [REDACTED]. WE ARE SUCCESSFUL IN KILLING KENNEDY. CERTAINLY IN THE FACE OF SUCH AN ACT VICE PRESIDENT LYNDON JOHNSON WILL NOT GET INVOLVED WITH US FOR A LONG TIME. TO THIS END, GET IN CONTACT WITH "YOUR FRIENDS" SO THAT THEY WILL GIVE YOU THE INSTRUCTIONS WHICH THEY HAVE RECEIVED THROUGH THE APPROPRIATE CHANNELS. YOUR TACTIC SHOULD BE TO CONTINUE DEMONSTRATING YOURSELF AS ANTI-COMMUNIST, MORE SPECIFICALLY ANTI-CASTRO, AS YOU HAVE. UP TO NOW YOU HAVE PLAYED YOUR ROLE VERY WELL AND YOU HAVE BEEN SUCCESSFUL IN COMPLETELY DECEIVING THE F.B.I. YOU ARE AN ARTIST. BY THE WAY, ARE YOU ALREADY SPEAKING OVER THE RADIO AGAINST FIDEL? HOW IT WILL MAKE ME LAUGH TO HEAR YOU. THE F.B.I. CANNOT COPE WITH US. THEY ARE EMBECILES, CRETINS. I HAVE DECIDED TO SEND YOU THIS BY MAIL SINCE YOUR "ANTI-COMMUNIST" ADDRESS CERTAINLY WILL NOT BE "CONTROLLED" BY THE F.B.I. FURTHERMORE I DO NOT WISH TO TAKE ADVANTAGE OF OTHER MEANS THE SPECIFIC AND DETAILED INSTRUCTIONS OF THE PLAN WILL BE SENT BY MEANS KNOWN TO YOU. ANSWER BY THE SAME MEANS. FIDEL IS VERY ANXIOUS TO KNOW HOW THE PLANS ARE PROGRESSING. I SALUTE YOU. SIGNED "PEPE". P.S. HOW IS YOUR WIFE? GREET HER AND YOUR BROTHER WARMLY. END LETTER.

"Comrad Rodriguez,

"In accord with the planning and obstinant attitude of Kennedy to invade Cuba carry out the attempt on his life in the terms conceived. I am not giving you more data because it is not necessary since all that you have to know you know, and for its own security and effectiveness of the planning I comply thus with superior orders.

"I have had no other way of communicating this to you by any other safer means, for that reason I had to do it by letter. In the U. States they are not in habit of opening the letters for that reason I trust everything will go well. A good communist has to run these risks. We have to count on our own energies because USSR has not adopted a solid position with Cuba. These are high level questions that a good communist (card carrying) should not question.

"If he does it in that way it will be for the good of all communist that are in the world. Cuba is not all. Enough already has been done by Cuba.

"I will send you the next news if I am able by a far safer method. Give me a prompt answer. I am embracing you. - Pepe"

The envelope, written in English, was postmarked Havana, Cuba, 9:00 A.M., November 14, 1962, and bore the address 9246 7 N.W. and 11432 St., Washington, USA. The letter, written in Spanish, is dated Havana, Cuba, November 13, 1962.

On December 10, 1962, Informant 1-15-45 advised of a letter recently intercepted, dated November 5, 1962, from Havana, Cuba. This letter was addressed to one Carlos Meneses, P. O. Box 347, Guatemala City, Guatemala. 1-15-45 disclosed that a substantial portion of the letter states:
